The legislation includes democratic reforms, social and legal fields, research and implementation of world experience in our country, and some received in the new edition. In recent years, in recent years, the electoral legislation of our country has been carried out in recent years. One of these is adopted by the Election Code of the Republic of Uzbekistan on June 25, 2019, and the unique legislation of the electoral legislation, and the division of many legislation in the field of election law, and the election of many legislation. At present, the lives of society and people, lifestyle, scientific and intellectual potential and knowledge in the political legal sphere, the achievements of science, technology and cultural processes develop rapidly. In this regard, the legislation of the country, in particular, changes in the election code this year amended and supplied. According to him:

"In Articles 14, 20, 22, 101 and 102 - excluding the consideration of complaints on the actions and decisions of election commissions under the powers of higher election commissions;

Article 21 - Desrag election commission on the election of the President of Uzbekistan, Deputy Chairman, Deputy Chairman, Secretary of the Commission and the Secretary of the Commission, and a member of the 11th law;

Article 31 - Removal of the norm on the performance of the candidate, the position of candidate (training type), place of work;

Article 38 - To determine whether the citizens can confirm the identity along the passport through the passport by supporting the political parties or candidates in the elections;

Article 48 - Public events such as voters meetings with voters The place and time of their conduct shall be carried out at least three days ago, to determine whether the permit required for these public events.

The Legislative Chamber was adopted by the Legislative Chamber on January 29, and the law approved by the Senate on February 5 was held in October. In particular, this year's presidential election is on October 24 "[6]. The essence of these changes is provided for decent and convenient harmonia for the abolition and analysis of our country's experience for the abolition and implementation of our country for foreign countries.

While we are now on the history of elections since the years of our country, we have witnessed many elections. If we only receive the process and history of one of them, candidates for the presidency of the Republic of Uzbekistan shall meet the requirements of the identity. The same person may not be President of the Republic of Uzbekistan for more than two consecutive terms. The President of the Republic of Uzbekistan shall be elected by the citizens of the Republic of Uzbekistan for a five-year term by secret ballot of general and universal and direct confection. The procedure for electing the President shall be established by the Law of the Republic of Uzbekistan "[7]. The first presidential election in the history of independent Uzbekistan was held on December 29, 1991.In it, two candidates of the Republic of Uzbekistan were promoted their programs, which was a candidate from the People's Democratic Party of Uzbekistan Islam Abduganievich Karimov and the spokesman for the ER Herk Democratic Party.94.2% (9.9 million US dollars) took part in the elections. In this election, Islam Karimov won with 87.1% of the

results of 87.1% and became the first president of the Republic of Uzbekistan. The 1991 president's uniqueness of the elections is characterized by the presence of "All Karshi" voting competition. Interestingly, the number of people voting for this position was more than 36,000. The planned period of office elections will be on January 5, 2000 (March 26, 1995, the issue of the nationwide referendum will be held on the extension of the presidential term. This initiative supports 99.6% of those participating in the referendum, and the president's employment will be extended until 2000). Two candidates for the presidency are competing: Abdulhafiz Jalolov, a candidates for the Presidential Party, from Fidokorlar party. The 2000 election is most of the most voters in the history of our country, ie 95.1% of voters. According to the election, the candidate from the Federokor Party is the victory of the 95.7% of voters totaling. The next election to be held in December 2014 shall be once filed with molotational elections with the parliamentary elections and will be held for 3 months in March

2015. The election in this election, a candidate from the Vote from the Movement of Entrepreneurs and Businessmen - the Liberal Democratic Party of Uzbekistan, will win absolious victory. The candidate from the Democratic Party of Uzbekistan "Milliy Tiklanish" Akmal Kholmatovich Saidov 3.08% of the People's Democratic Party of Uzbekistan Hotamjon Abdurahmanovich Kobmonov 2.92%, Uzbekistan KO from the

Social Democratic Party of UzbekistanNarimon Majitovich Umarov will receive a 2.0% of the vote [8].

The deadline for the presidential election is scheduled for the death of the incumbent President Islam Karimov in 2016 in 2016 (January 2, 2016). The election company was allowed 9/10.
