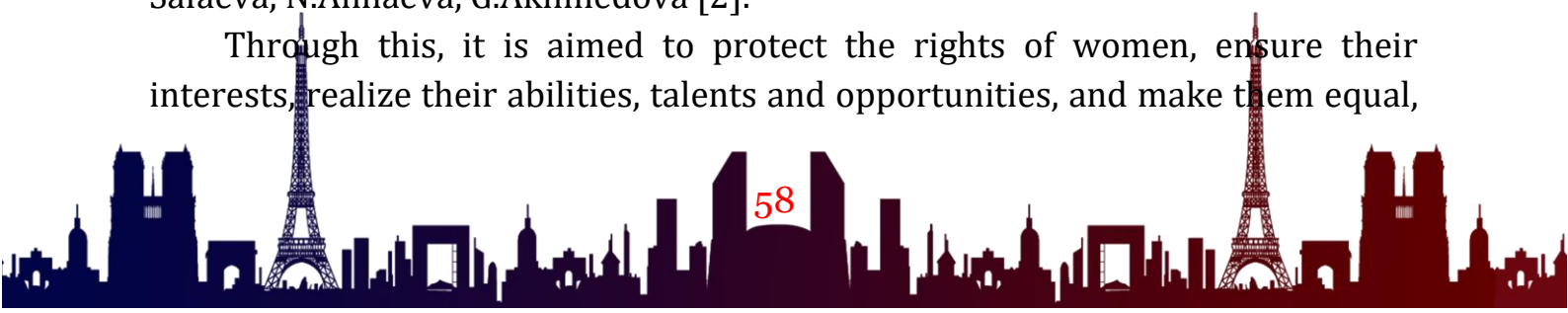

scientifically justifying that raising legal culture among women is a necessary condition for preventing harassment and violence.

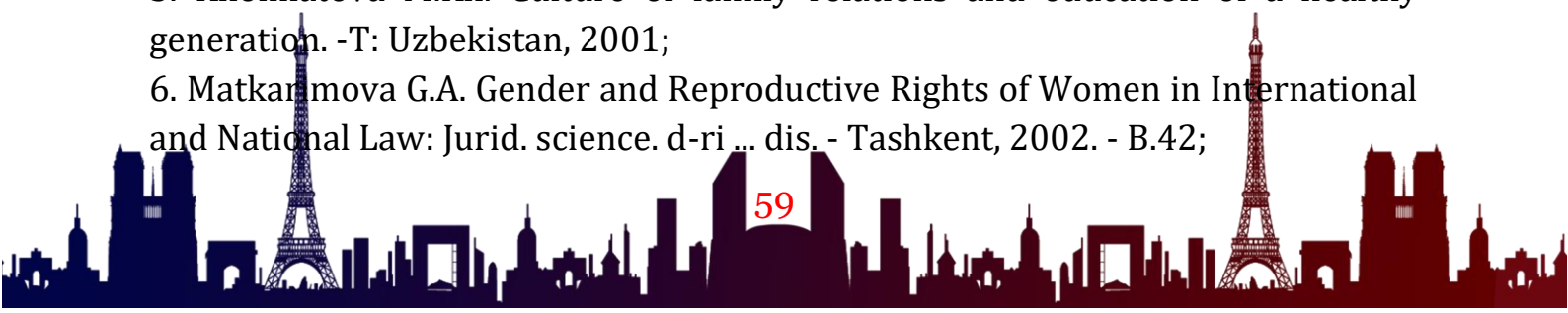
Research that increasing women's socio-political activity is an important factor in ensuring gender equality in the country
