- Execution completion court document The two-month mandatory enforcement actions specified in the law will be carried out, and the enforcement document will be enforced in the cases specified in the law or will be terminated based on the decision of the state bailiff to terminate the enforcement work in accordance with other articles of the law.
- Other organs documents execution verb order from c ud documents outside , row state organs decisions and decisions of officials authorized to impose administrative fines are binding execution This is to documents the following includes :
  - Tax bodies decisions ( debt collection about ).
  - Administrative fines about decisions .
  - Banks and credit organizations with related documents .
